

DP World London Gateway Environmental Policy

DP World London Gateway comprises the development and operation of a deep sea container port and logistics park. DP World London Gateway considers that effective environmental management of construction and operational activities is key to developing a sustainable business, enhancing environmental performance and preventing pollution. Working in a sustainable and responsible way is essential to building a strong business for our customers, our people and our society.

DP World London Gateway has a structured Environmental Management Systems (**EMS**) for the *Management of the environmental impacts relating to the construction and operation of the DP World London Gateway Port & Logistics Park Development*. The EMS is certified to the international environmental management standard ISO 14001. The EMS assists DP World London Gateway in achieving the DP World Global 'Our World, Our Future' sustainability strategy, in particular the environmental priority areas of climate change and ocean Protection.

In addition to this global strategy, DP World London Gateway is also committed to:

- complying with the requirements of relevant UK and International legislation and other compliance obligations;
- protection of the environment; including prevention of pollution and ensuring measures are implemented to determine and manage environmental risks and opportunities during construction and operation;
- lowering natural resource use and carbon emissions where possible and working with organisations to achieve environmental improvements within the supply chain;
- implementing an air quality strategy and a carbon and energy reduction strategy including lowering emissions where possible through the Planet Mark certification process for the Port and Park;
- establishing objectives and targets to effectively manage significant environmental aspects associated with construction and operations and monitoring our progress against these;
- implementing the local sustainability strategy through a range of community engagement programmes focussing on education, enhancing skills and knowledge, job creation and economic growth;
- actively engaging with local communities, businesses, regulators and other interested parties, thereby forging partnerships for now and for the future; and
- continual improvement of the EMS to enhance environmental performance.

DP World London Gateway will provide management and staff with the necessary resources, equipment, information and training to be aware of their responsibilities for the implementation of this policy, to ensure that environmental issues are given adequate consideration in all relevant areas.

All employees and contractors are expected to cooperate and assist in the implementation of this policy, whilst ensuring that their own works, so far as is reasonably practicable, are carried out without risk to themselves, others or the environment. This includes cooperating with management on any environmental related matter.

The UK Chief Executive Officer has ultimate accountability for the effective management of environmental risks and opportunities and is supported by the DP World London Gateway Senior Management team in implementing the commitments described in this policy into business strategy and processes. The implementation of this policy and the associated arrangements will be monitored and reviewed on a regular basis by DP World London Gateway to ensure that they remain current and applicable.
